NOTICE TO EXHIBITORS

Entry fee shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competition by action of the Show Committee. Errors on entry forms are the responsibility of owners.

The show grounds will be open from 8:00 a.m. until 6:00 P.M. on Saturday. All dogs must be removed after show hours. Grounds will reopen at 8:00 a.m. on Sunday. The show is planned for outdoors.

*****THERE IS ABSOLUTELY NO CHALKING IN THE BUILDING*****

Dogs need be present only at the scheduled time of judging according to the judging program that will be mailed to exhibitors. Dogs not required for further judging will be excused. Judges will not wait for any dog holding up a class. Cash prizes will be paid in the ring to the person showing the dog, who will be considered as the owner or authorized agent. Claims for prize money must be made in the ring before judging is over, and the Secretary advised at once. The management and show-giving club disclaim any liability for cash prizes after the judging is over. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fee will be made.

“Effective for all shows held on or after July 1, 1980, dogs which according to their owners’ records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent or Show Secretary at least 1/2 hour prior to the start of judging at the show.”
